### **Aquatic Invasive Species Workshop**

Twenty-four residents attended the Aquatic Invasive Species workshop at the Wasa Community Hall on August 16<sup>th</sup>. The workshop, presented by the East Kootenay Invasive Plants Council (EKIPC) and the Wasa Lake Land Improvement District, covered the threats and impacts of aquatic invasive species, prevention strategies, identification of native vs non-native plants, and sample collection techniques. ### **Section 9 Application Underway**

Responding to residents' concerns expressed at the Aquatic Invasive Species workshop, trustees voted at the August 17<sup>th</sup> board meeting to file a Section 9 Application under the Water Act (Approvals and Notifications of Changes In and About a Stream) to request government permission to deal with milfoil.
